When submitting an application for an entitlement that requires public notification, the following items are required:

radius line touches any po be numbered to correspon owner's name, the propert property owner information	<b>Mailing List</b> – A list of the property owners within the required radius are from the project site. If the radius line touches any portion of the lot (or lot line) it must be included on the mailing list. The list must be numbered to correspond with the numbers assigned on the radius map, and must include the property owner's name, the property owner's mailing address, and the assessor parcel number for each lot. The property owner information provided must be obtained from the latest Los Angeles County Assessor's records (see attached example). Privately owned mapping agencies also provide this service for a fee.


